

## Narrandera Shire Council: Plan B – Win a Swag Competition | 'CONDITIONS OF ENTRY'

1. Information on how to enter and prizes and any details form part of these 'Conditions of Entry'. Entry into the promotion constitutes deemed acceptance of these Conditions of Entry. Entries must comply with these Conditions of Entry to be valid. This promotion is governed by the laws of NSW.
2. Entrants acknowledge and agree that this is a competition of chance, that each submitted entry will enter into the Promotion and that a winner will be randomly selected.
3. The promoter of this promotion is Narrandera Shire Council, 141 East Street Narrandera 2700 ('Promoter'). The Promoter's decision in all matters is final and no further correspondence will be entered into.

### ELIGIBILITY

4. Entry is only open to persons who meet the following criteria: ('Entrants'):
  - a) who are Australian residents;
  - b) ordinarily reside in New South Wales;
  - c) who are over 18 years of age;
  - d) who are a resident of NSW;
  - e) are not:
    - i. contracted Council Road Safety Officers by Transport for NSW; or
    - ii. immediate family members of any of the persons in the preceding sub-paragraph.
5. The Promoter may request any Entrant at any time to provide reasonable evidence that s/he meets the eligibility requirements listed above and failure to do so will result in disqualification from this promotion.

### PROMOTION DATES

6. The promotion starts on Thursday 17 April at 12:01AM AEST and ends on Sunday 27 April at 11:59PM AEST ('Promotional Period').

### HOW TO ENTER

7. To enter the promotion, Entrants must, during the Promotional Period:
  - a) Like and provide a comment giving their Plan B on a relevant Narrandera Shire Council Facebook post; and
  - b) Be contactable by Messenger based on their Facebook profile.
8. Each submitted like and comment on a relevant Facebook post that complies with the above criteria generates one entry ('Entry') into the promotion. Only one Entry is allowed per person per post within the Promotional Period. The same person cannot win a Prize twice within the Promotional Period.
9. The Promoter accepts no responsibility for any Entry that is late, lost, incomplete, incorrectly entered or misdirected or for any technical difficulties or equipment malfunction (whether or not under the Promoter's control) during the Promotional Period.

### PRIZE JUDGING

10. A total of 1 Winner ('Winner') will be drawn at the end of the Promotional Period.
11. Random Draw software will be used to draw winning Entry. The drawn Entry must meet the Eligibility Criteria. If the drawn Entry does not meet the Eligibility Criteria, another Entry will be drawn.
12. The winner will be contacted within 7 days of the end of the Promotional Period. Each Winner will be notified via Facebook Messenger.

### PRIZE DETAILS

13. The Winner will receive a Oztrail Swag (value greater than \$200).
14. The prize will need to be collected from the Promoter. The Promoter is not responsible for delivery of the prize.

### PRIZE CLAIM DATE

15. Each winner will be contacted as outlined above (clause 10). The Winner must respond, accepting the Prize by Friday 30 May 2025 11:59AM AEST ('Prize Claim Date').

### UNCLAIMED PRIZE ARRANGEMENTS

16. If a prize is not claimed by the Prize Claim Date or a Winner, the Promoter will award the Prize to another Entrant as per judging criteria as outlined above (clause 10). The relevant time limits will be extended as convenient and in the absolute discretion of the Promoter.

### GENERAL

17. A prize is not transferrable or exchangeable and cannot be taken as cash. A prize must be taken as offered and cannot be varied.
18. Subject to any written directions given by Liquor & Gaming NSW, the Promoter will not replace or substitute a prize or provide compensation where a Winner is unable to claim or use a Prize for any reason including cancellation or discontinuance or unavailability of the Prize.

The Promoter reserves the right to request the Entrant produce appropriate photo identification or other documentation (to the Promoter's satisfaction, at its sole discretion) in order to confirm the Entrant's identity, age, and residential address before issuing a Prize. If the documentation required by the Promoter is not received by the Promoter within the time frame outlined or where an Entrant's eligibility has not been verified/validated to the Promoter's satisfaction, the Entry will be disqualified from this promotion.
